## **OUTWARD TELEGRAPHIC TRANSFER FORM**

## Terms and Conditions Governing the Application of Telegraphic Transfer

The Telegraphic Transfer Application (the "Application") of Ayeyarwaddy Farmers Development Bank and its branches (the "bank") is made subject to the following terms and conditions.

- 1. The Applicant shall ensure the accuracy and completeness of the information provided in the Application.
- 2. The Bank shall not be liable for any loss or damage whatsoever due to:
  - I. Erroneous or incomplete information given to the bank
  - II. Unavailability of good funds or insufficient funds
  - III. Delays or faults or any kind in the Transaction, or in any message or instruction by mail, facsimile, telegraph or cable
  - IV. Delay or error or failure in locating or identifying the beneficiary
  - V. Refusal or inability of the Bank's correspondent or agent to effect payment by reason of any law, regulations, guidelines, court orders, directives, act or decree of any government of regulatory authorities
  - VI. Any other cause of reason whatsoever beyond the Bank's and its correspondent of agents control
- 3. Unless agreed by the bank, all payment instructions are not revocable. Unless payment in a different currency is allowed by the country where the transaction is payable to, payment is to be made in the currency of the country where the transaction is made payable at the buying rate of exchange of the bank's correspondent or agent.
- 4. The transaction and the processing of the payment instructions are subject to the rules, regulations and market practices of the country where payment is to be made to. The Bank shall not be liable to any loss or delay caused by any such rules of regulations of market practices.
- 5. The applicant shall not reclaim bank charges once the transaction has been processed or failed or rejected due to the reasons mentioned in Condition No. (2).
- 6. The Bank may refuse to process the payment instruction if the funds in the Applicant's account are insufficient and charges applied will be deducted from the Applicant's account.
- 7. The bank will not allow for all transactions to countries under the sanction list.
- 8. The Bank reserves the right to reject the Application without having to furnish any reason for doing so.
- 9. The Bank is allowed to provide this transaction and related information to the Central Bank of Myanmar or any government authority of the Republic of the Union of Myanmar when requested.
- 10. The Terms and Conditions are applicable and governed under the Republic of the Union of Myanmar Laws.

- 6. PRO-FORMA INVOICE (Original) FOR ADVANCE TRANSFER
